1. Developmental Psychology. An in-depth survey of theory and research in developmental psychology throughout the lifespan. Dr. Walsh's course introduces students to the biological, cognitive, emotional, social, and linguistic development from the prenatal period to late adulthood. Courses of instruction and expertise include:

1. Terms and concepts used by developmental psychologists to study human development and the theories of researchers who have shaped the discipline.
2. The effects of heredity, maturation, and environmental factors on individual's emotional, social and physical developmental throughout their lifespan, with discussion of some modern developmental problems like technology use.
3. Scientific reasoning applied to developmental claims made in the media and the popular press.
4. Major aspects of social and emotional development from attachment theory, psychosocial and social learning perspectives.

5. Cognitive development using Piagetian, Vygotskian, and information processing perspectives.
6. Ways that cognitive, physical and social development interact with each other.
7. How gender, family, race/ethnicity, and culture affect development.

2. Psychology of Health Counseling. Examines health counseling methods designed to promote good health and prevent illness, deal effectively with the treatment people receive for medical problems, help people cope with and reduce stress and pain, and aid in the recovery, rehabilitation, and psychosocial adjustment of patients with serious health problems. Courses of instruction and expertise includes:

1. The interplay among physical well-being, psychological and social factors.
2. How to apply psychological health counseling to promote health and wellness.
3. The stress response and its impact in the etiology and course of health problems.
4. Applying behavioral and cognitive methods to help individuals cope with stress.
5. Proposing programs to improve personal health habits and lifestyles.
6. The difficulty patients experience in deciding whether or when to seek treatment for disturbing symptoms, physical or emotional.
7. The experience of patients in the hospital setting, factors that affect adherence to medical regimens, and sources of problems in patient/practitioner relationships.
8. Psychological and medical methods for relieving pain.
9. Explaining the use of psychological methods and principles to help patients manage and cope with chronic illness.

3. Introduction to Psychology. An introduction to the theories, research and applications that constitute the field of psychology. Emerging issues in the field of psychology, what different types of psychologists do, and how to critically evaluate psychological literature. Courses of instruction and expertise:

1. Psychology as a science. Psychological principles, treatments and methods.
2. Definitions of psychological terms.
3. Stages and components of psychological theories, methods, and processes.
4. Psychological theories, their theorists, assumptions, and concepts.
5. The extent to which psychological theories, research designs, and measurement tools can accurately account for, clarify, and predict underlying mechanisms of human thought, emotion, and behavior.
6. Evaluation of the validity of statements dealing with behavior and mental processes.
7. How to break down complex behaviors and mental processes into interpretable components.
8. How to think critically about psychological principles, concepts, theories, and methods.

9. Identify ways that psychologists demonstrate ethical principles.
10. Sensitivity and acceptance of characteristics of diverse life-styles.
11. Methods of intellectual inquiry (*i.e.*, locating, comprehending, and synthesizing information from multiple sources into a single, coherent scholarly product).
